**CALENDAR YEAR 2023**  
**MODEL ORDINANCE TO EXCEED THE MUNICIPAL BUDGET**  
**APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK**  
**(N.J.S.A. 40A: 4-45.14)**

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Mayor and members of the Township Committee of the Township of Franklin in the County of Gloucester finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Mayor and members of the Township Committee hereby determines that a 1% increase in the budget for said year, amounting to \$117,908.13 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Mayor and members of the Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Mayor and members of the Township Committee of the Township of Franklin, in the County of Gloucester, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Township of Franklin shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$412,678.45, and that the CY 2023 municipal budget for the Township of Franklin be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED**, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

**BE IT FURTHER ORDAINED**, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, the mailing of estimated tax bills will enable the Township of Franklin to meet its financial obligations, maintain the tax collection rate, provide uniformity for tax payments and save the unnecessary costs of borrowing; and

WHEREAS, in accordance with Chapter 72, P.L. 1994, the Township of Franklin Chief Financial Officer and Tax Collector have computed an estimated tax levy in accordance with N.J.S.A. 54: 4-66.3, and they have both signed a certification showing the tax levy for the previous year, the tax rates and the range of permitted estimated tax levies; and

WHEREAS, the general tax rate is detailed on Attachment A.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Franklin, County of Gloucester, State of New Jersey, as follows:

1. The Tax Collector of the Township of Franklin is hereby authorized and directed to prepare and issue estimated tax bills for the Township of Franklin for the third installment of 2023 taxes.

The Tax Collector shall take such actions as are permitted and required by Chapter 72, Public Laws of 1994 and N.J.S.A. 54:4-66.2 and 54:4-66.3; and

2. The entire estimated tax levy and the estimated tax rate for 2023 are hereby set as shown in Attachment A.
